NorthWest Apple Pickers Board Meeting, December 16th, 2008 (Digest)

The December Board Meeting was called to order at President Camp's home at 7 p.m., December 16, 2008, and adjourned at 8:21 p.m. Three Board members were absent, there were no guests present.

The reports shows a balance of \$1275 in all accounts with the Red Chip value ending the year at \$31.50. Membership stands at 73. December meeting attendance figures: New User Group was 17 including one visitor and General Meeting was 14, including one new member. No Novice SIG was held and the iWeb SIG was cancelled because of forecast weather conditions. The New User Group featured a round table discussion wrapping up the first annual training cycle on Leopard. The General Meeting was our annual Holiday Potluck (delicious) and Swap Meet which ended a bit early because of snow flurries.

January meetings will start with a one day shift from first Thursday to Friday the 2nd because of New Year's Day. The Novice SIG will meet at 3 p.m. at the Lakewood Library (upstairs), the New User Group will meet at 7 p.m. to begin the annual cycle on Leopard 10.5. The Mortvedt session will meet Friday, January 9th. The General Meeting will convene at 3 p.m. on January 11th to review and vote on the proposed Bylaws; Erick Camp will then demonstrate the application Audacity. The iWeb SIG is scheduled at the Summit Library, 5:45 p.m. Wednesday, January 21st, a day after the January 20 Board Meeting.

The Gift Committee noted that there were more items acquired for gifts at the December Party than were distributed. It was agreed that these will be offered as a second drawing item after the Red Chip at the next several meetings.

The Board approved the purchase of the sound system President Camp has assembled which worked well at the December meetings. The President was also authorized to change the Internet hosting service for the club's website after the beginning of the New Year to select an ISP that offers more storage space than our present plan. He will work with Webmaster Beels to move the files once the new service is established.

NWAP's public image is created by its publications: the newsletter, the website, flyers, brochures, and business cards. The Board discussed ways to assure the messages we distribute are consistent in content and appearance as well as appropriate. The Board will further discuss the structure of the publications chain of command. The

Editor prepared a description of duties and responsibilities which included criteria for selection of material and photos to publish. The Board voted to adopt the criteria.

View Your RSS Feeds in Mail

Excerpted from Cool Mac Apps: Twelve Apps for Enhanced Creativity and Productivity, 3rd Edition by John Tollett and Robin Williams

To make it easier to get your info fix, you can send your RSS feeds from the Safari web browser directly to Mail. Then, whenever you check your mail, you can see whether you have news articles waiting to be read. To send an RSS feed to Mail, make a bookmark of the RSS feed (press Command-D). In the resulting dialog box, check Mail to add the bookmark to Mail. Click Add, and it's done!

Tom's Mac Notes January 2009

MagicJack internet telephone is still under test. Have not shut down my expensive QWest service yet. All problems with MagicJack seem to be operator (my) error. There are MagicJack user's forums out there and I see lots of complaints, mostly about the company and/or their business practices. I can't comment from personal experience as since ordering the product I have had only a few minor dealings with the company.

Part of the internet (problem) side of my MagicJack troubles had to do with my Apple Airport Extreme router. I have been testing it for almost a month and the net result is that I must sadly report that it gets two thumbs down. Sometimes it worked as a wireless router and sometimes the signal was nowhere to be found. My Mac Mini, connected to the Airport by ethernet cable, sometimes could only get on line via wireless. Included instructions are somewhat vague. During setup you are supposed to know (for example) if you want to configure IPV4 using DHCP or some other equally (to me) obscure protocol. The unit has a USB port that you supposedly can use to hook up an external hard drive (or thumb drive) which can be accessed by any computer on the network. That did work for me. About once in 50 tries. Sad. The Airport has been replaced by something from Cisco.

Upgraded my MacBook from original 1GB memory to 2GB. Easy. Didn't have the recommended Phillips size 00 screwdriver to remove 3 screws holding in the bracket. A flat blade jeweler's screw driver, smallest you have, works OK. I don't see any difference in operating speeds. But, I don't ever have more than two or three programs open at once.

Metafilter is an interesting WEB site.

Found a browser there called Plainview that is different. Minimal browser graphics intruding on your screen territory.

I did splurge Euro 6.99 on Squirrel, the finance program mentioned a month or two ago. It is still in beta. Squirrel 1.0 will be Euro 25. I hope they get the problems fixed as I like the on-screen look of Squirrel. I'll have free upgrades until version 1.9 (if

that ever happens which I think has less than a 50-50 chance.) I was told that my last problem (failed imports) would be fixed shortly and a week later the new version with the import "fix" was released. Still doesn't work. I'll forget about it for a few months and download whatever version is available then.

I never get tired of looking for the "perfect" finance program. Haven't found it yet. Install of Windows versions of Quicken and Microsoft Money (two different versions of each) failed. Crossover Pro couldn't deal with them. The Microsoft Money failure doesn't surprise me. Crossover Pro has been tweaked for a number of the latest Microsoft programs but not Money. Tried Liquid Ledger trial version. That does a great job of importing a QIF file with multiple accounts. But the trial isn't very usable. And its cost is more than I want to spend at \$50. Then I stumbled upon a free program called Cashbox. A whiz at importing that multiple account QIF file.

Check the Student Union at your local college or university for Apple products. At my local school MacBooks start at \$855. Minis are \$20 off what they are at the Apple Store. Not much but every little bit helps. Recently saw a refurbished Air at Apple on-line for \$1,200.

What Gender Is A Computer?
