NorthWest Apple Pickers Board Meeting, Jan 20th, 2009 (Digest)

The January 20th Board Meeting was called to order at President Camp's home at 7 p.m. and adjourned at 8:21. One Board member was absent and one Guest present.

Reports showed the Red Chip value has reached \$47.50 and the Treasurer noted last minute disbursements had substantially reduced the balance reported earlier of \$1388. The club has 73 active memberships. Attendance at the New User Group was 19 and at the General meeting, 18. During the month we had 3 new memberships and 4 renewals.

The Novice SIG met at Lakewood Library and will meet in February at the Steilacoom Library. The New User Group has begun the annual cycle and will review the Finder at the February meeting. The final iWeb SIG is scheduled for January 21. Mortvedt Session is scheduled for February 13. The General Meeting Presentation in February will be Sound Studio.

The proposed Bylaws were approved at the January 11 General Meeting and a copy of the final version will be distributed to members with their February newsletters. At that meeting the members also voted to establish a club Historian. The Board began working on a job description for Historian, as well as the duties for all other elected and appointed positions which will be formally added to the Standing Rules.

A candidate slate has been assembled for the March Election of Officers. One candidate was unable to meet on the traditional Board meeting day so the Board voted to reschedule the Board Meeting to the first Tuesday of the Month effective March 3, 2009. Both former and newly-elected Board members will be invited to the April 7 Board Meeting.

In reviewing meeting schedules the Board also noted that April's General Meeting needs to be rescheduled from the second Sunday (Easter this year) to the third Sunday (April 19) just as the May General Meeting is delayed one week because of Mother's Day.

Newsletter submittal deadlines will change in March to the third Monday of the Month.

The nwapplpkrs.org website was transferred to a new hosting service on January 7 without problems. There are some mailbox management issues still being sorted out.

An audit of the books will be scheduled in February in anticipation of the change of Treasurers.

A committee was authorized to search for a wide aspect-ratio projector (which will replace the current 4:3 model) with appropriate connections and features at a price not to exceed \$750.

transferring from one to the other is easy--and difficult. The professionally correct method of prudently selecting and managing the items I choose to move from the old to the new has sadly slipped into the old haphazardly traditional method: grab that old junky folder and haul it over to the new machine: I'll go through a fix it later (of course.)

For us Macintosh users, this marks the Twenty-fifth Anniversary of the Mac. America got its first glimpse of the future in 1984. That little one-piece machine used a mouse to navigate around its tiny black and white screen and used small hard plastic encased "floppy" disks to store its system, software, and output, since it had no hard drive. That Graphical User Interface made What You See Is What You Get computing possible and soon created the Desktop Publishing revolution. Only a decade ago, in 1998, Apple introduced the iMac.

A century ago Wilbur Wright had just set a couple of aviation records in France, flying for more than 120 miles in a little over 2 hours while Louis Bleriot was putting the finishing touches on his little monoplane that would carry him across the English Channel a few months later to win the London Daily Mail prize. Technology was changing transportation, communication, arts, government, and expectations as the telephone, the Model T, and electricity expanded the world for more and more people.

So here, with resources available within seconds on my Mac accessing the Internet, I have prepared another article, ready to send to the editor, who will use desktop publishing to assemble this newsletter and transmit it to a printer. Milestones or millstones? We just keep marking those cycles, counting events, and celebrating those great or small passages of time, don't we?

Tom's Mac Notes

EditGrid is an online spreadsheet. If you know Excel you know EditGrid. Easy and fast signup to use EditGrid for personal use. I uploaded an Excel spreadsheet and it looked good except for my needing to align one column via the usual toolbar alignment command (after highlighting the column). Made a few changes and hit File Save. Got a message saying ?Spreadsheet changes are always automatically saved. There is no need to save changes manually.? So, if you can see any need for an online spreadsheet give it a try.

I wish Google Docs was as easy to use as EditGrid. (GD is actually quite easy once you get the hang of it.) Or, that EditGrid had a word processor element. Did go back to Google Docs to give the word processor another try after a year of non-use. GD still remembered me and an old spreadsheet was still there. Am writing this month's Notes online so I can switch back and forth from the Mini in the computer room and the laptop in the kitchen. No worries about which Mac has the latest version of the Notes.

Am always looking for a better notes program to stash my many year's worth of passwords and other info. Have tried such programs as Sidenote, MacJournal, Circus Ponies, NoteMind, etc. Still like Jotz. Most of these programs fall down (not Jotz) in the search department. Here is a new one (new to me) called NotePad. You can find it by searching on NotePad 2.6b1. Supposed to be a clone of a Mac OS 9 desk accessory. Search works across various files stored in this new version of NotePad. Check out the products at neXtSoft.com. I like NotePad enough that I was happy to make the suggested \$5 donation via PayPal.

Still testing MagicJack internet telephone system. If you think this has been going on for a long time you are right. The main problem: My antique Dell laptop which was not reliable enough to consistently work as my MagicJack "server." A modern Dell desktop lost its ability to connect to the internet. As the Ethernet connection was built in and not a card I could not fix the problem. Then I got a cheap "thingy" on EBay that is an Ethernet to USB

NorthWest Apple Pickers By Laws

January 2009

ARTICLE I

Name

The name of this organization shall be NorthWest Apple Pickers Macintosh Users Group. This Group will hereinafter be referred to as NWAP.

ARTICLE II

Purpose

The purpose of NWAP shall be to provide a nonprofit, educational, self-help organization for users of Apple/Macintosh personal computers; to cultivate cooperative relationships among computer users in our community; and to promote knowledgeable use of Macintosh hardware and software.

ARTICLE III

Members

Section 1. Membership is on a household basis and is open to all upon submission of a membership application and the payment of the dues. Spouses, partners, and children residing in the same household may all be active members (if they so desire) under the single dues payment of one household member.

Section 2. Annual membership dues are set by the Executive Board.

ARTICLE IV Section 1. Club Meetings

A. General Meeting shall be held once a month, except there will be no meeting in August. General Meeting in March shall be the Annual meeting for the purpose of elections and any other business.

- B. Executive Board Meeting shall be monthly at a location determined by the President of the Board.
- C. A notice of at least 15 days prior to these meetings will be given to the membership.

D. Quorum

- 1. A quorum shall consist of no less than ten of the membership at Membership meetings.
- 2. At Board of Directors meetings a quorum shall consist of a simple majority of the members of that Board

Section 2. Special Interest Group (SIG) Meetings

SIGs may be AUTHORIZED by the Executive Board.

ARTICLE V

The elected Executive Board shall consist of five Officers and three Directors who shall have voting rights at Board meetings.

The Officers of NWAP shall be President, Vice-President, Secretary, Treasurer, and Membership.

Section 1. Specified Duties

A. President shall:

- 1. preside at all Board and General meetings.
- 2. appoint, with the consent of the Executive Board, Special Interest Group Leaders and other Committee Chairs.
- 3. exercise final responsibility for ensuring General and Executive Board meeting locations and availability.

B. Vice President shall:

- 1. assume the responsibilities of President in the case of the President's absence or incapacity to serve.
- 2. be Program Chair and arrange for all General meeting presentations.
- 3. perform such other duties as the Executive Board may assign.

C. Secretary shall:

- 1. keep minutes of official meetings and make them available for publication.
- 2. maintain the official copy of the current Bylaws and Standing Rules.
- 3. perform such other duties as the Executive Board may assign.

D. Treasurer shall:

- 1. collect all monies due as authorized by the Executive Board and provide receipts.
- 2. provide a monthly financial report to the Executive Board.
- 3 submit to the Executive Board a year-end financial summary report by January 31st for the previous calendar year.
- 4. promptly pay all debts incurred by NWAP and authorized by the Executive Board.
- 5. provide access to NWAP's financial records for the Audit Committee within 14 days of the assumption of duties of new officers, and at such other times as the Executive Board may direct.
- 6. perform such other duties as the Executive Board may assign.

- E. Membership shall:
 - 1. maintain an appropriate record of members.
 - 2. prepare mailing labels and maintain current email addresses for distribution of materials to members.
 - 3. report monthly meeting attendance information to the Executive Board.
 - 4. perform such other duties as the Executive Board may assign.
- F. Directors shall perform such duties as assigned by the President and approved by the Executive Board.

Section 2. Vacancies

Vacancies among Officers or Directors shall be filled by the Executive Board for the remainder of their term.

Section 3. Roles and Responsibilities

Executive Board shall define and publish roles, authority, and responsibility as Standing Rules.

Section 4. Composition of the Executive Board

The number of members comprising the Executive Board may be amended in accordance with Article VIII.

ARTICLE VI

Committees

Standing Committees

Section 1.

Standing Committees shall be established in the Standing Rules.

Special Committees

Section 2. Special committees may be appointed as needed by the President with the approval of the Executive Board.

ARTICLE VII

Parliamentary Authority

The rules contained in the current edition of Robert's Rules of Order shall apply.

ARTICLE VIII

Amendments

These bylaws may be amended at any General Meeting provided that notice has been given by the Executive Board at least one month in advance. Amendments shall require a 2/3 vote of members present.

ARTICLE IX

Dissolution

Dissolution shall require approval of a majority of members in accordance with Article IV.

(Approved January 11, 2009)

General Meeting Minutes, Sunday, January 11, 2009 (Digest)

Members of NorthWest Apple Pickers met on January 11, 2009 to consider proposed bylaws.

President Camp called the meeting to order at 3:10 p.m. at the Lakewood Library. The reasons for revising the Bylaws, last modified in 1996, were reviewed. Amendments were approved to remove a specific day of the month for Executive Board meetings are scheduled, to add definition of a quorum for General and Executive Board meetings, and to add a section defining requirements for approving dissolution.

A proposal to create an additional member of the Executive Board to act as Historian was modified after discussion. An appointive position of Historian is to be created. It may be filled by a member serving on the Executive Board or someone from the General Membership. Thus, the Executive Board will continue to be comprised of 8 members: 5 officers and 3 directors.

The formal General Meeting was adjourned at 3:51 p.m.
