concepts, new techniques, and new tools. Perhaps it is a mark of my advancing years but it seems that "new" is happening at an increasing rate. Revolutionary inventions are rare (and probably always have been.) Evolutionary inventions are much more common. Add a neat new minor technological device to an existing product and stand by! An example is the solid state memory chip which is the basis for digital camera cards, flash or thumb drive memory sticks, and the solid state drives which may eventually replace mechanical hard drives in our computers. That personal computer we rely on is an evolutionary critter, too. From vacuum tubes to transistors to circuit boards, the components shrink in volume and expand in capability. From Eniac to the iPhone, what an evolution. A simple evolutionary step may create a swift revolutionary change in the way things are done as a new product or process sweeps out the old and establishes the new.

Here we are in the Summer of 2010. Nine years ago it was the iPod. Three years ago it was the iPhone. This year it is the iPad. All devices that were new combinations of existing products and technologies mixed with attention to user interface. Each staked out new territory in their respective markets. Each become the target for competitors to beat. Each changed the way their owners connect to the technological grid we all belong to these days. E-publishing, Podcasts, music and video distribution are just a few of the industries that have been profoundly affected.

Perhaps this will be the year that some far future edition of Wikipedia marks as the point when the

# Be Aware of **iTunes** Password Caching

A brief tempest of recent blog posts highlights a design compromise that Apple made with App Store and in-app purchases from iOS devices.

To summarize, designer Mike Rohde bought an app on his iPad and, while waiting for it to download, his 7-year-old son played a free aquarium app called Fishies that offers additional items for sale via in-app purchases. Without realizing what he was doing, Mike's son purchased a number of items within Fishies, including a chest of pearls priced at \$149.99 - he racked up almost \$200 for the day.

Reasonably enough, Mike went ballistic when he saw the bill from iTunes. Luckily, despite the iTunes terms stating that all sales are final, he was able to call Apple Support and have the largest charge refunded.

#### TOM'S MAC NOTES AUG. 2010

**USB3.com** is one of the good places to go for USB3 gear. Don't overpay for USB3 stuff when you can go (for example) to USB3 and get a 3 foot A to A USB3 cable for about 5 bucks.

Search for MacLife in the iPhone App store. Good informative app and it is free from MacLife Magazine.

I wondered if PC Magazine was still in business. My subscription lasted for many years but is long defunct. If it is still being published it no doubt is much reduced in size. I still have the February 29th, 1988 issue on my computer desk. Apparently PC Mag was published several times a month 22 years ago. The 1988 copy I have is 462 pages in size and there are reviews (tests) of 55 word processors. Anyone for Microsoft Windows Write?

First I heard of this place: **Vanns.com**. Mentioned in Consumer Reports in a list of best online merchants. I didn't do hardly any comparison shopping. Did notice that Mac Minis were the same price as at the online Apple store. You might save a bit on shipping (mostly free) and tax at Vanns.

This might come in handy. It sure did for me. I downloaded a long document from my insurance company, 54 pages. I only needed the first three pages so as soon as they printed I turned the printer off. Thinking this would purge the remaining 51 pages in the printer's memory. Gotcha! The queue is in my Mac, not the printer. Not easy to purge. Here's how: Start terminal. Enter this command: cancel -a-(And of course hit Enter.) All done.

Speaking of printers: Just replaced my old Samsung laser with a newer Samsung ML-2525. Much quieter as the old machine liked to keep running (fans?) after a print job. The new one was on sale for \$69.95. (Two weeks later it was \$59.95 at the same store.

So what happened? Developer Manton Reece explained it well in his own blog post. In essence, because Mike had purchased an app on his iPad and then let his son play with Fishies immediately afterward, iTunes cached Mike's password and used it when his son made purchases within Fishies, instead of requesting it again. Mike's son was prompted for each purchase, but since the iOS didn't require a password, it's easy to see how a 7-year-old could agree to the in-app purchase prompts without realizing what was happening.

This entire situation came about because of a design compromise. By requiring you to enter your iTunes account password for a purchase or free download, Apple ensures that an authorized user is in control of the device. That's a good thing. And by caching the password for 15 minutes, Apple reduces the significant annoyance of typing passwords (especially strong ones that include numbers and punctuation) on a virtual keyboard. In general, that's also a good design, although it can obviously have unintended side effects.

To eliminate those side effects, Apple could require a password for every purchase or free app download, but that would hurt the overall user experience. In most instances, there's no need to prompt multiple times for purchases made in quick succession because it is most likely that they're being made by the same authorized user.

Arguably, Apple could also cache the password separately for app purchases and in-app purchases, such that purchasing an app wouldn't enable in-app purchases without requiring a password. However, there's no telling if such a change would be easy to make or if it would make a significant difference, since any sort of caching will allow inadvertent purchasing.

The Board voted to accept the reports.

The proposal to print business cards was discussed. President Camp had circulated an email to Board Members describing the costs and options he has researched. The Board agreed to order 500 cards with a color logo on the the front with postal address and web site information. The text on the back-to assure the info would not go stale-was suggested to read:

A mockup in PDF form will be developed by Bob Moffat and circulated to Board Members for approval before authorizing printing by Minuteman Press.

Several potential topics for future meeting presentations were discussed, including use of audio books, ebooks and ibooks, and online resources like the Pierce County Library system.

The club's MacBookPro currently is running 10.6 Snow Leopard from an external drive. The 10.5 Leopard installed internally has been retained so that we could demonstrate the Windows Vista using Parallels v. 3.0, which is not compatible with 10.6. A larger drive, donated to the club, is available to install in the MacBook. Peter Winderling will research the installation process for the hard drive. The Board agreed that the installation of 10.5 Leopard, which is now rarely used, could be discarded, so long as pertinent files are copied.

There is no General Meeting in August. The Board agreed to cancel the scheduled August 8th Board Meeting and turn the reservation back to the Library.

The meeting was adjourned at 2:23 p.m.

# **New User Group Recap**

July 1st By Bob Moffat

To remind us of the versatility of iPhoto, we reviewed several of the ways this software can make it easy to manage and edit our digital images. We demonstrated ways to organize and view photos as Events and Albums. Editing tools permit the adjustment of images in several ways from simple enhancement to straightening and cropping. Color, exposure, and sharpness controls are available. Preset filters offer special effects that may be fun, as well. We explored how to use batch processing to add information to the descriptions to a selection of images at one time.

Images in iPhoto can easily be attached to email messages. We explored at least three ways that can be done and discussed the options offered for selecting the size of the attachments.

The ability to add location information via the "Places" feature was demonstrated and some of our members noted their pictures taken with their iPhones already included that data. The "Faces" feature uses face recognition to identify people and establish a gallery which permits you to quickly find all the photos in your library in which in individual appears.

As we begin vacation time, this review of the iPhoto features can serve as a reminder of the many ways to store, organize, edit, and share the results of our Summer shutterbug season.
