Net Neutrality Yes or No?



The Federal Communications Commission has proposed new rules governing the Internet. The public and other interested players, such as the major cable companies and corporations who use the Internet to make money, will have about 6 months to make comments about the proposed changes.

In the past two decades that Internet has been allowed to evolve and develop within an inclusive government regulation in the U.S.A. That may be about to change.

Please check this topic out and consider the costs that you and I may face if some of the proposed changes go into effect. Let your representatives know what you want.

that is a tempting thought, after all that work studying and meeting academic requirements. Reality sets in quickly for most of us, however. Learning is a lifelong process. *You snooze*, *you lose*.

You could pick any year in the past and find folks pondering the same question. The amount of information generated continues to grow exponentially, even if the part that you really need to know may be even a small portion of the total.

Fortunately, the tools to manage the pile have also evolved. We don't have to memorize it all. We don't have to maintain a personal library with millions of books. We have the Internet to store it. We have access to the Internet to look it up.

Granted, not everyone has computer access and not everyone would want to use a computer to search for the answer. But in the last couple of decades the technologies surrounding storage of humanity's knowledge base and access to it have been transformed. If you don't believe me, Google it. Check out Wikipedia.

The World Wide Web provided a way to see what was stored. Digital technology created a way to convert real stuff into virtual digital stuff, which takes up less space. The personal computer and smart phones and tablets made access to this stuff portable. The current issue about Net Neutrality has arisen because changes are proposed to allow some service provider entities to purchase faster/better service, potentially limit speeds for customers unwilling to pay, or permit service providers to decide which content they will allow. After all these years of a "level" playing field where there was no such restrictions, the changes are concerning. Fortunes have been made (and lost) when everyone from Mom N. Pop to Big Bucks Inc. shared the same level of access to use the 'Net.

In my opinion there should be no way corporations increase their control over what can move on the Internet. It's not as if these folks are losing money under the present system! The reason the Internet has become a universal communications channel throughout the world has been its openness and lack of filters or *filterers*. I wonder if we would have witnessed some of the important historical events of the past decade if All Technical & True Inc. had been offering access only to the "ins" or the "haves" during the Arab Spring or the recent events in Crimea.

So, here we are at the end of another year of schooling (for us all.) And we are looking forward to Summer Vacation. Only this time it looks like we need to keep our thinking caps on! As usual, we'll have no time off from learning...and we may need to work extra fast if we want to preserve easy open access to the Internet before the Biggies start metering what we can look up. Time to let the Powers That Be know we don't want to be Have Nots.

Can An Open Internet Have Fast Lanes? -- Fundamentally, the idea behind net neutrality is that any Internet user should be able to access any legal content or service — using any legal device — in a non-discriminatory manner. That is, network operators shouldn't be able to block, degrade, or play favorites amongst content and services based on their own business interests or other factors. This essential equality — that traffic from multi-billion-dollar companies like Apple is treated with the same priority as a goofy snapshot from your kid sister — has been a major factor in making the Internet an economic and cultural force, not just in the United States but worldwide.



Meeting was adjourned at 2:50 PM. Respectfully submitted, Judy Sloan, Secretary


Open House and Potluck on June 8

NWAP MacBookPro for sale

The **2.2GHz 15.4**-inch MacBookPro which the club has used since the Fall of 2007 has been replaced. This machine arrived with 10.4 Tiger installed and an installation DVD for 10.5 Leopard (which had just been announced.) Through the years we continued to update it all the way through 10.9 Mavericks (although this machine lacks some of the hard ware that are needed for several recent OS X features and runs a bit warm with Mavericks.) It has a fresh copy of Mt. Lion 10.7 installed.

The model designation is **3,1** and the order number is **MA895LL/A** if you look for price comparisons online with other **Mid/Late 2007 MBP**s. It has 4 GB of RAM. We replaced the battery (now has about 40 loadcycles on it and a remaining capacity of 5295 mAh) and installed a larger hard drive (now has 320 GB.) This Mac has been gently used during its six and a half years, having been powered up each month for four meetings and several addition hours for program preparation.

NorthWest Apple Pickers members will have the opportunity to purchase at the June 8th Open House and Potluck Picnic. Sealed bids may be submitted at the June 5th New User Meeting and on June 8th up to the grand opening ceremony. The highest bid will win (you need not be present to win.)

In late May, prices online for used MBPs of this model appear to range from low \$500s to mid \$700s from such sources such as Powermax.com, Amazon.com, and GainSaver.com.
